Information clause for customers and suppliers of MAWOS Sp. z o.o.

In accordance with Article 13(1) and 13(2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, (General Data Protection Regulation, GDPR) (OJ L 119/1) we hereby inform you that:

- 1. The controller of your personal data is MAWOS Sp. z o.o. with its registered office in Łódź 92-614, ul. Rokicińska 299/301, NIP [Tax Identification Number] 7280132389, hereinafter referred to as the "Controller". - 2. Your data is processed for the following purposes:
 - 2.1. conclusion and performance of commercial contracts,
 - 2.2. performing the Controller's legal obligations, i.e. issuing and storing invoices and accounting documents, paying taxes, responding to complaints etc.,
 - 2.3. ongoing contacts and e-mail correspondence,
 - 2.4. marketing activities such as customer satisfaction surveys, information on changes, new product versions etc..
- 3. Your personal data is processed only to the extent that it is relevant for the above purposes. Provision of personal data is voluntary, however the lack of consent to the provision of the same makes it impossible to conclude a commercial agreement (name, surname, company name, NIP [Tax Identification Number], address of residence/company registered office address, PESEL [personal identification number]), to conduct correspondence (e-mail, telephone number).
